With more than 20 in-person and online events organised every year, there are plenty of opportunities to share your knowledge, get personal exposure, and network with peers at AIJA and partner events.

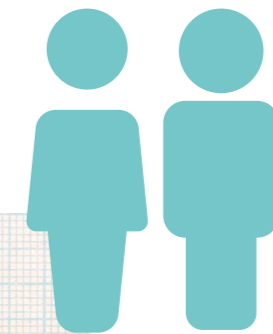

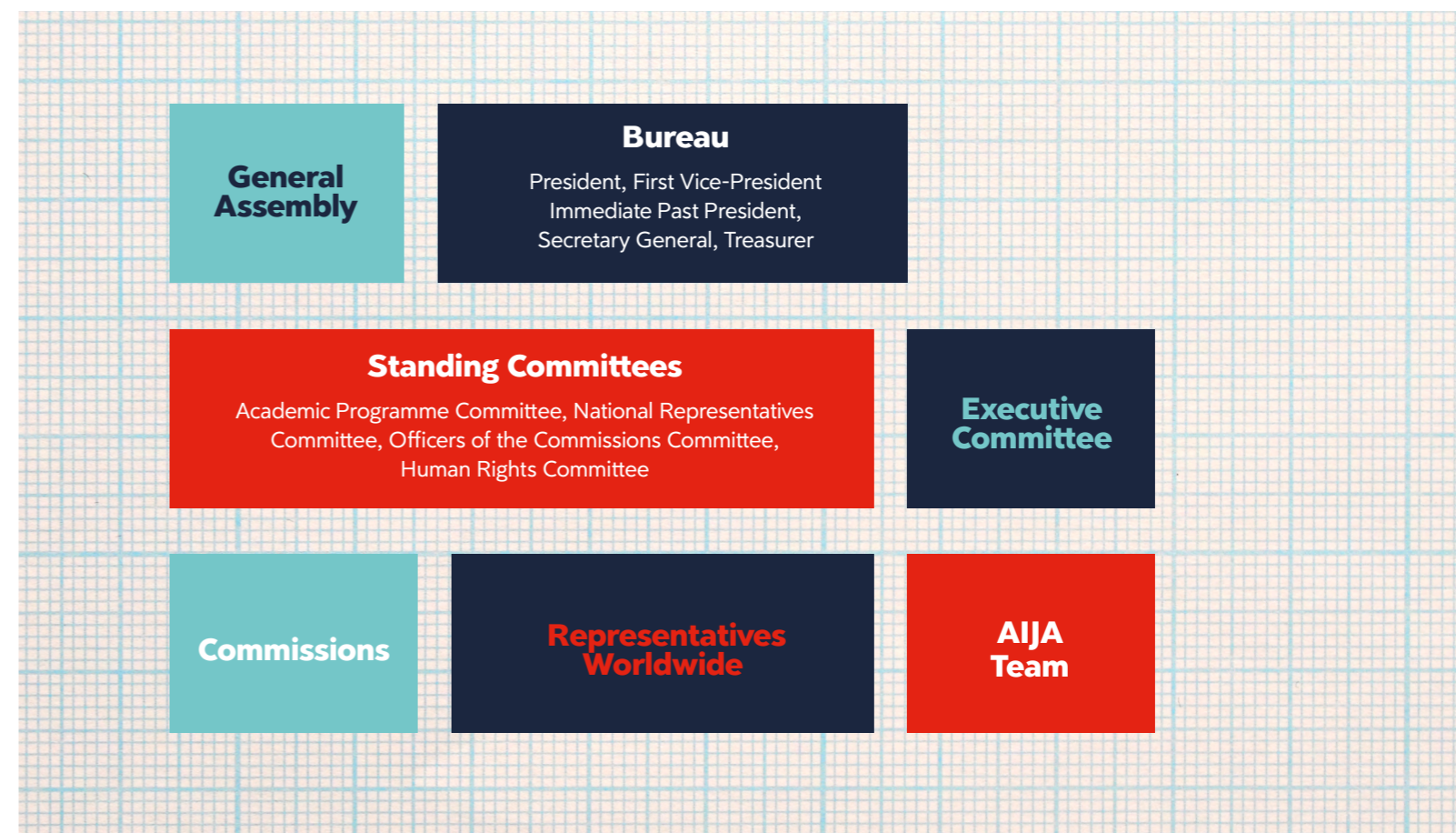
## Scholarships

## Commissions

The 21 AIJA Commissions cover major law practice areas and professional interests. AIJA events are organised and run by members through the Commissions. The Commissions also publish newsletters or reports. They meet regularly during the year. Each Commission is led by a President and supported by Vice-Presidents.

## Bureau

The association is administrated by a Bureau composed of five members: President, First Vice-President, Secretary General, Treasurer and Immediate Past President. The First Vice-President is elected by the ordinary General Assembly, one year before starting his/her one-year mandate of president of the association.

The Secretary General and the Treasurer are also elected by the General Assembly for 2-year mandates.



### **Standing Committees – the Extended Bureau (EB)**

The EB is composed of the co-chairs of the Officers of the Commissions Committee, the Academic Programme Committee, the National Representatives Committee and the Human Rights Committee.

### **Officers of the Commissions Committee (OCC)**

The OCC coordinates the activities of the Commissions and, through them, the substantive work of AIJA.

### **Academic Programme Committee (APC)**

The APC is responsible for the academic content of AIJA events. At its meetings, the upcoming seminars and other events are discussed and coordinated with Commission members involved in the events planning.

### **National Representatives Committee (NRC)**

The NRC is responsible for membership retention and recruitment activities, in coordination with Regional Coordinators, National, Local and Regional Representatives. At the local level, the AIJA National Representatives are the primary contacts for members.

### **Executive Committee (EC)**

The EC, formed mainly by 48 individual AIJA members elected by the General Assembly, assists and advises the Bureau and is responsible for approving applications for membership in AIJA, as well as for appointing the National Representatives of the countries represented in the Association. Each elected Committee member has a three-year term.

### **General Assembly (GA)**

The GA, composed of all members of the association having voting rights, meets at each Annual Congress. The Assembly decides on financial and governance matters. The Assembly also elects the First Vice-President, the Executive Committee members, the Secretary General, and the Treasurer notably through electronic voting.

### **Human Rights Committee**

The Human Rights Committee is involved in several projects dedicated to the protection of the rule of law and the right of every lawyer to practise their profession freely.

### **AIJA Team**

The AIJA Team provides secretariat support for the different membership groups and ensures timely implementation of all programmes and events.
