Local lawyers will open their homes for the most charming aspect of any Congress on Thursday evening – the traditional *Home Hospitality Dinner*.

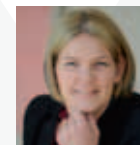

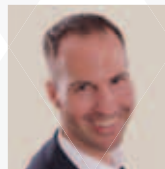
We are aware that the present result would not have been possible without the great support and cooperation of all commissions, general reporters and national reporters for which we are grateful.

WORKING SESSION 1

Market Standards for SPA's and Beyond

Are M&A lawyers creative enough? It is essential, in M&A transactions, to be familiar with current market standards in order to advise clients about possible negotiating positions and strategies. Therefore, we will present the findings of an M&A survey, which we conducted among a large number of AIJA members. Frequently, however, particular circumstances and problems call for creative thinking. Innovative M&A lawyers will face a lot of situations, where they need to find alternative solutions and compromises. During the working session, the participants will have the opportunity to work in teams to articulate creative solutions that go beyond the standard clauses.

The current worldwide tendency is, however, that jurisdictions aim for an increasing transparency regarding the income and assets of private as well as corporate taxpayers. During this working session, the speakers and panel members will address the international developments of transparency and the consequences for our clients. What transparency requirements and regulations do we have to take into account when advising our clients? And more importantly, what are the future structuring possibilities that we have?

WORKING SESSION 3

Arbitrating Energy Disputes: Hot Topics

Over the past decade, the arbitration world has seen a steady increase in the number of energy-related disputes. Energy (and the unlimited access to energy resources) has become an increasingly salient issue in international trade and business between privately owned entities and states alike. Accordingly, new energy disputes arise every day. This Working Session will cover three types of challenging disputes in the energy sector: (1) Arbitrating long-term contracts, in particular gas-price revisions, (2) arbitrating energy disputes under ISDS (ECT, ICSID etc.) and (3) arbitrating disputes relating to renewable energies (solar, wind and water). Are the arbitration rules suited to providing a stable, predictable and efficient means of resolving such disputes? What challenges do arbitral tribunals, institutions, practitioners and clients face in this context? What procedural issues regularly arise? How do these types of disputes change and challenge the arbitration world? This Working Session will address all of these highly interesting topics, will identify risks and challenges, highlight interesting cases from different perspectives and will equip you with the necessary tools to win your case.

WORKSHOP A

Knock Out the Infringer in One Round?

The Unified Patent Court (UPC) will shake up patent litigation worldwide. Very soon an entirely new court system will be in place, covering a bigger consumer market than the US. Finally companies across the world can knock out competitors with one single blow in Europe. This new system will attract new litigants from the Americas and Asia that did not litigate in Europe before. It will therefore affect any young IP lawyer anywhere in the world who is involved in international disputes. We will have a live (and lively) mock trial to illustrate the dos and don'ts. Two international teams will share their insights on the opportunities and challenges this new court system will bring. Let the show begin!

WORKSHOP B

The Quest for Coordination in Insolvency Proceedings

Main insolvency proceedings and secondary proceedings can only contribute to the effective realization of the total assets if all the concurrent proceedings pending are coordinated. The main condition here is that the various liquidators must cooperate closely, in particular by exchanging a sufficient amount of information. In order to ensure the dominant role of the main insolvency proceedings, the liquidators in such proceedings should be given several possibilities for intervening in secondary insolvency proceedings which are pending at the same time. During the workshop experienced insolvency practitioners having an international exposure will explore through a lively discussion and a case study the interactions between domestic legislation and international regulations and guidelines. The main goal shall be not only to scrutinize the complications associated with cross border insolvency proceedings through a thoughtful discussion about concrete issues and matters, but also to verify whether or not the quest for coordination in insolvency proceedings has been attained.

WORKSHOP C

Workers without Borders

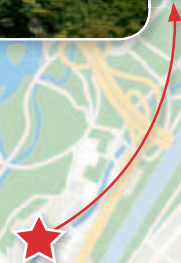

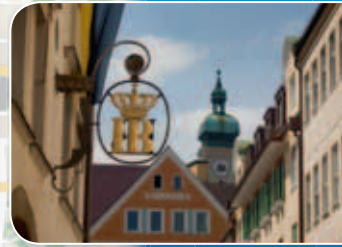

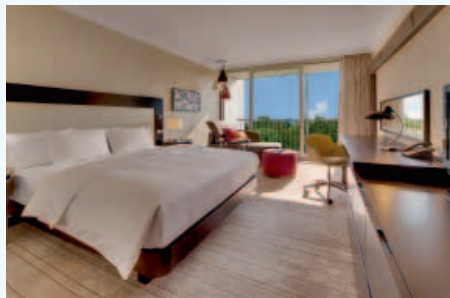

All delegates are responsible for making their own travel arrangements and checking visa entry requirements with their local Embassy or Consulate.

Transfer and transport between the Airport and the city centre

Munich has one airport: Franz-Josef Strauss Airport. Depending on traffic, it takes about 45 minutes to reach Munich City Centre by car. A taxi ride will cost you around €50. Buses and trains also depart from Munich airport to Munich city centre, every 20 to 30 minutes.

Insurance

Delegates are responsible for providing their own personal insurance. The organizers cannot be held responsible for any damage or loss.

Credit Cards

Major credit cards are accepted in most hotels, stores and restaurants.

Electric Current

Electric Current in Germany is the same as in most European countries, except the UK.

Electrical sockets (outlets) in Germany (Deutschland) are one of the two European standard electrical socket types: The "Type

C" Europlug and the "Type E" and "Type F" Schuko. If your appliance's plug doesn't match the shape of these sockets, you will need a travel plug adapter in order to plug in.

Weather in August

August is very nice and warm in Munich. Average temperatures: 25°C during the day and 10°C at night. A light jacket is preferred during the night time hours in Munich.

Tipping

Tipping in taxis, restaurants and hotels is not mandatory, but tipping for good service is appreciated, currently 10%.

Shopping Hours

Shops are usually open from 09.00 – 19.00 on week days and 09.00 – 16.00 on Saturdays.

Sanitary Information

No special measures must be taken for travelling to Munich and to the main tourist destinations in Germany.

Safety

Munich is a very safe city but, as in any large city, it is advisable to be cautious, particularly in crowded tourist destinations.
